One of the more known laws being passed is a law that bans conversion therapy, a practice performed by therapists usually forced upon children by their parents so parents can 'change' their LGBT youth to be straight. Conversion therapy subjects youth to a higher risk to suicide, mental illness, shame, helplessness, etc. while it also makes students feel unsafe and unheard in schools. "Parents shouldn't be allowed to send their children to

conversion therapy. In the end of everything it doesn't change them and it only puts them more at risk." LGBT kids with non-supportive families are subject to 8.4 times more likely to attempt suicide. "Students should be allowed to be themselves, not be forced into a box of others morals." Trinity Mason '20 said. The topic of conversion therapy is just now being talked

about, and many hope that the laws will be passed.
"Conversion therapy is horrible. It should be outlawed. I've had a few students who have made their children go through

conversion therapy; it's bad." Margaret Motz said.

In 2018 California is in the process of passing a law protecting non-binary persons called the 'Gender Recognition Act.' In many schools across America transgender or non binary students still struggle when it comes to changing their gender on a school website or even using the restroom during the day. This act recognizes the people who don't identify for either gender and want the choice to put it on their birth certificate. Majority of states in the U.S allow for gender change of male to female (vise versa) on your birth certificate but do not allow a third option.
